Sir,

I S.I. Paresh Barman of Matigara P.S do hereby lodge a Complaint to the effect that on 17.07.2021 at 12:25 hrs I received a information from reliable source that one Tractor without number plate loaded with stolen river bed materials coming from Balason Jali Busty side. On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Balason, jail Busty under Matigara P.S area, I found said Tractor loaded with river bed materials going towards jail Busty Subsequently, I manage to stop the vehicle and asked the driver to produce valid documents / papers of the said river bed materials, but he did not produce any valid documents in support of said stolen materials. As such I arrested the driver namely Hira Sarki (21), S/O Sher Bdr. Sharki of Sainikpuri, Khaprail Bazar, PS - Matigara, Dist - Darjeeling and also seized the above noted loaded truck under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought to the above noted bricks at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle namely Hira Sarki (21), S/O Sher Bdr. Sharki of Sainikpuri, Khaprail Bazar, PS - Matigara, Dist - Darjeeling and the seized vehicle without number plate under proper section of law and arrange for its investigation.
