Tha along with my husband Samrat Chakraborty had appointed one Kisho Chhetri son of unknown resident of Kurseong presently residing at Bot Company More Jyotinagar Siliguri as the caretaker for the purpose looking after my plot of land as well as tin roof structure thereon and oth belongings in the said premises.
