Subject: First Information Report.

Sir,

In producing here with one arrested persons namely Pulokeshi Kanjilal(52) S/O Lt. Jiban Kanjilal of Ganesh Ghosh Colony,Ps.Pradhan Nagar,Dist-Darjeeling along with following seized articles :-

- (1) One white carry bag containing stupefying medicines Winspasmo Fort Capsuls (each capsules contains Dicyclomine Hydrochloride 10 mg, Tramadol Hydrochloride 50 mg, Acetaminophen 325 mg) total 57 strip each strip containing 8pieces total 456 pieces capsule as mother packet marked as Exhibit-A.
- (2) 02 (two) strips of "winspasmo forte" capsules, each strips containing 08 capsules (total 16pieces) taken from mother packets exhibit "A" as sample marked as exhibit "A-1" for examination.

I beg to report that, today i.e. on 17.07.21 at 19:25 hrs I have received source information from one person namely Pulokesh Kanjilal of Ganesh Ghosh colony under Ps.Pradhan Nagar selling illegally procured spurious drugs to young youths at Ganesh Ghosh Colony area and its adjacent area under PS Pradhannagar from his house and has stock huge quantities in his house to obtain huge profit .I diarised the fact vide PDN Ps GDE No. 1111 dt. 17.07.21 and informed I/C Pradhan Nagar Ps . As per instruction and direction of I/C Pradhan Nagar Ps. without making any delay myself along with PSI. Kalyan Saha .ASI. Debasish Das ,ASI Ratan Pradhan, CV 131 Ranjan Sharma, CV 646 Baban Das , CV/645 Pankaj Gupta of Pradhan Nagar PS left the Ps to work out the information at Ganesh Ghosh Colony under Pradhan Nagar Ps/Spc. Arrived at Ganesh Ghosh Colony under this Ps at about 19:40hrs .Source pointed the house then, I have hold raid in the house of Pulokesh Kanjilal and recovered one white carry bag containing stupefying medicine form his Showcase . On counting found 57 strip in the carry bag each strip 8spices Capsule of Winspasmo - Fort (Tramadol HCL, Acetaminophen & Dicyclomine HCL )Capsules. On being asked the person in respect of such possession, he stated different statement at different times, which arouse suspicion that he is procured the same illegally for its clandestine disposal. Further he also could not produce any papers or any license in support of such possession of strips of capsules. On further interrogation the apprehended person stated that he is selling illegal drugs at that locality for his wrongful gain.

Accordingly, I have seized all capsule under proper seizure list duly signed by witnesses and accused person and labeled at the PO . Seizure was made in between 20:05hrs to 20:55hrs I explained the charge and arrested him by issuing memo of arrest.

Hence, I request you to kindly register a specific case under proper section of law against above noted arrested persons namely Pulokesh Kanjilal(52) S/O Lt. Jiban Kanjilal of Ganesh Ghosh Colony,Ps.Pradhan Nagar,Dist-Darjeeling under proper sections of law and arrange for its investigation.
