Sub: - Written complaint against 02(two) Toto Drivers. Ref: - Panitanki T.G. GDE No. 1141/21, Dated-19.07.2021.

Sir,

I S.I. Dinesh Chandra Barman of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 19.07.2021 around 09.45 hrs, I have received information that some Toto vehicles without any registered number are stationed at Major Road Airview More in such a way blocking the free flow of traffic and casing hindrance to the general public and other vehicles.

Accordingly, I SI Dinesh Ch. Barman alongwith ASI Sujoy Sarkar and forces had been to the spot near Airview More, Siliguri around 09.45 hrs and found the above noted Toto vehicles along with drivers had been stationed in such a manner disrupting the free flow of traffic causing hindrance and danger to the general public and other plying vehicles. On being asked they disclosed their name as-1) Partha Das S/O Nikhil Das approx 20 years, Male. Address- Ambika Nagar, Bhaktinagar Jalpaiguri and 2)Shyamal Das S/O Satish Das approx 31 years, Male, Jogomali, Fokdoibari Jalpaiguri.

Further on being asked them to produce relevant document in support of their claim of plying Toto on Major Road, but they failed to produce the same. Hence, they committed the cognizable offence disturbing the free flow of vehicular traffic and endangering the life and free movement of public in general. As such I arrested them U/S 41 Cr. PC after preparing proper arrest memos and briefing them about the ground of their arrest in proper way. Thereafter, I also seized all the 02(two) Totos from their respective possession after preparing proper seizure list in presence of local witness and duly attested by them and took into custody. After their arrest the above noted accused Toto drivers have been released on Bail and PR Bonds. Provided them copies of seizure list of their respective Totos which were kept in Airview TG premises.

Hence, I would, therefore request you to kindly start a specific case under proper section of Law against all the above noted accused Toto drivers and obliged.
