I Dal Bahadur Rai, holding a pension accounts in State Bank of India would like to report a series of theft/ unauthorized transactions from my accounts.

The first unauthorized transaction that I came across in my account- 10697327712 was of ₹9999/- on 04.07.21. Particulars of the transaction- INB IMPS / P2A / 118501758980 / XXXXXX201PUNB eCHO: MOAESCCY16. The second transaction also happened in the same account on 05.07.21 of ₹500/-.

The other unauthorized transactions happened in my account - 20047096379. Amount of ₹51,000 was debited on 08.07.2021. I was puzzled and immediately rushed to the bank to report regarding the above mention transaction, I was notified about the Yono platform, described as an online platform for banking transactions. They also revealed that a loan was sanctioned against my FDs. Surprisingly, I am an old veteran with old school of thought operating my keypad mobile for basic use only. Though, I was asked by the bank manger to dissolve one FD and pay the loan amount. Which cost me another ₹64,861/-, which I paid on the belief of bank and understanding that they will look into these unauthorized transactions in my account fairly.

As far as I know My registered mobile number is 9435410321 and I never changed or activated Yono app on this number. I am a retired veteran and my livelihood is solely depended on the pension I receive, so please look into the matter at the earliest and provide me with necessary aid.

I would be obliged and truly grateful for the action taken. I hope this will suffice your requirement, for any further clarification I remain available.
