In producing herewith Seven(07) arrested accused persons who disclosed their names as (i) Santo Halder (18yrs) S/O- Sushil halder of New Town, Rajarhat, PS-Rajarhat, Dist-North 24 Parganas (ii) Prasanta Roy (20yrs) S/O- Jagadish Roy of New Town Rajarhat, PS-Rajarhat, Dist-North 24 Parganas (iii) Sunil Mandal (61yrs) S/O- Lt Chand Mohan Mandal of Niranjan Nagar, Ghugumali, Ward No-36, PS-Bhaktinagar, Jalpaiguri (iv) Hasim Raza (32yrs) S/O- Md Ajimuddin of Islampur Matikunda, PS-Islampur, Dist-U/DNJ A/P- HC Road, Zaika, near Shree Bhawan Market, PS-Siliguri, Darjeeling (v) Ramkumar Paswan (21yrs) S/O- Mina Paswan of Sushilnagar, PS-Singhhal, Dist-Begusarai (vi) Nitish Kumar Paswan (25yrs) S/O- Ramuchit Paswan of Begusarai, Linga, Mirjapur Chand, PS-Banoni, Dist-Begusarai (vii) Krishna Paswan (27yrs) S/O- Rajpati Paswan of Maniappa, PS-Mathiri, Dist-Begusarai. I, SI Mihir Majumder of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 23.07.2021 at around 20.25 hrs during my Mobile Van duty myself along with my accompanied force had been to Venus More, Siliguri and found that the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and without valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15,05.2021 and Order no-713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021, 753/II-ISS/2M-22/2020 dated 28.06.2021and 753/III-ISS/2M-22/2020 dated 14.07.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accounding, I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
