Sir,

With due respect, I am producing herewith the arrested accused person namely Jagadish Roy (52 yrs) S/O late Naren Roy of Amaidighi, Fulbari PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 22 (Twenty two) bottles of 60 up Himalayan Gold Country Spirit containing 600 ml in each bottle of MRP Rs 100/- of each bottle.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 24.07.21 at 18.15 hrs I received a secret source information that one person namely Jagadish Roy of Amaidighi, Fulbari is selling ID liquor illegally at his shop at Fulbari Border Road under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 1287 dated 24.07.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, C/1053 Paresh Rava and CV/824 Niru Kr Yadav left for Fulbari Border Road to work out the information in hand. At about 18.45 hrs we arrived at the shop of accused Jagadish Roy at Fulbari Border Road and being shown and identified by the source we held raid at his shop and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his wrongful gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 19.05 hrs hrs to 19.45 hrs on 24.07.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Jagadish Roy (52 yrs) S/O late Naren Roy of Amaidighi, Fulbari PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
