I, S.I. Order in c/w Covid-19 pandemic as declared by the State Govt. Of West Bengal vide Government Order vide No.403/2020-DM-1 (A) Date-29.04.2021 Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons (i) Alok Das (25), S/O Biren Das of Pundibari, PS - Pundibari, Dist - CBR, (ii) Chandan paul (57), S/O Mohanlal Paul of Gali No. 136, H-Bihar, Delhi, (iii) Raki Paswan (42), S/O Chhehodu Paswan of Krishna nagar, Patna, (iv) Abdul Kalam (38), S/O Abdul Saikh of Debidanga, PS - PDN, Dist - DJG, (v) Ranjit Ghosh (39), S/O Halanath Ghosh of Saktipur, Murshidabad under proper section of law and arrange for its investigation.
