J.N Paul of Hakimpara, W/No. 16, PS-Siliguri, Darjeeling (iv) Sk. Saidul (32yrs) S/O- Sk. Khalakh of Haiderpara, Ward No-39, PS-Bhakitnagar, ,Dist-Jalpaiguri (v) Suparno Sanyal (32yrs) S/O- Dipak Kumar Sanyal of Ashrampara W/No. 12, PS-Siliguri, Darjeeling (vi) Subir Kr. On being asked, the above noted person stated before me that, he is well aware of the pandemic situation and all the orders of Government as well as local administrations regarding COVID-19.

Hence, he violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- x 713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021, 753/II-ISS/2M-22/2020 dated 28.06.2021 and 753/III-ISS/2M-22/2020 dated 14.07.2021. The above noted person have intentionally refused to comply with the order of Govt, of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the State as well as country. Accourding, I arrested him u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused person and arranged proper investigation of the case.
