I, SI Subir Chowdhury of Matigara PS SPC to the effect that on 29.07.2021 while performing SPL Mobile duty under Matigara PS area found Three persons namely (i) Bikram Karjee (28), S/O Sri. Ram Charan Karjee of Kalabari, PS - APD, Dist - APD, (ii) Anikul SK (31), S/O Kismat Sk of Purba Para Colony, PS - Suti, Murshidabad, (iii) Abhijit Roy (28), S/O Bablu of of Morabhanga, Chatomari, Sitalkuchi, Dist - CBR were loitering at Khaprail More, under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt.
