  - 1. That on 26/07/2021 my father has accompanied with Rehana Bibi for lodging complaint against 1. Raju Ali son of Ansar Ali, 2. Rohima Bibi wife of Ansar Ali, 3. Monohara Bibi wife of Raju Ali, 4. Salima Khatun daughter of Raju Ali, 5. Maibu Ali, son of Raju Ali, and 6. Merina Bibi wife of Raju Ali all resident of Shantipara, P.O. Bhaktinagar, P.S. He has got such many stich on his head and back side of his body.

Under the above circumstances I humbly request you to take necessary action against the aforesaid accused persons as per provisions of law and for such act of kindness I shall remain extremely grateful to you.
