He disclosed his name as mentioned above. I demanded him to produce papers or license, Cash memo of the said liquor but he failed to produce any documents in support of possession of above noted illicit liquor and spirit. Then I seized the above noted illicit liquor and spirit under proper seizure list in presence witnesses and also labelled the same. The whole process of seizure and labelling was made in between 15:40 hrs to 16:40 hrs. On interrogation, He admitted that he procured the liquor, spirit illegally and had been selling them illegally to the people. Thereafter, I arrested him u/s 41 Cr.P.C. by preparing a proper memo of arrest in presence of witnesses. I, therefore pray before your honour to take legal action as per law against the accused person namely Bittu Kizku (28),S/O-Dhumu Kizku of Purba Rangia, PO New Rangia, PS Matigara, Dist- Darjeeling under proper section of law.
