
In this regard, I beg to state that today on 30/07/2021 at about 16:15 hrs. while performing special mobile duty vide GDE No. 933 DT: 30/07/2021, received information that some people are violating the order of Lockdown and roaming aimlessly at Chathat Medical More. Accordingly informed the matter to O/C, Matigara PS and as per his direction, I along with force had been to Chathat Medical More under NBMC & Hospital OP and arrested the above noted 12 accused persons. Thereby completely violating the lockdown measures issued by Chief Secretary West Bengal vide order no. 618-ISS/2M-22/2020 DTD.30/04/2021 and 622-ISS/2M-22/2020 DTD. 1st May 2021 issued by the Ministry of Health & family Welfare, Government of India Order no. 403/2020-DM-1(A) Dtd.29/04/2021. On seeing police, they tried to flee away but somehow, the above noted persons could be apprehended. On interrogation, they disclosed their name and address as noted above. On further interrogation, they admitted that they were aware of the lockdown Order and Restrictions imposed upon the movement of human being and shops. As they have violated the Lockdown Order promulgated by the appropriate Government Authority and also the provision of Disaster Management Act, 2005. Hence I with the help of force arrested them U/S 41 CrPC by issuing them memo of arrest and lodged this complaint against them.

I, therefore pray that a specific case under proper section of law may kindly be initiated against the above noted arrested accused persons and arrange its investigation.
