In producing herewith nine (09) arrested accused persons who disclosed his name and identity as (i) Mithun Kr. (26 Yrs) S/o- Jalil SK. of Binnaguri, Jarepakuri, Fulbari, PS-NJP, Dist-Jalpaiguri, (iii) Bappa Dey (47 Yrs) S/O-Lt Chandan Dey of Champasari Anchal near Shree Guru Vidyamandri, PS-Pradhannagar, Dist-Darjeeling, (iv) Sitam Rai (23 Yrs) S/O-Agam Rai of Gurung Busty Near Sandy Fitness, (Jim), PS-Pradhannagar, Dist-Darjeeling, (v) Pradip Kamti (37 Yrs) S/O-Laxman Kamti of New Colony junction, PS-Matigara, Dist-Darjeeling, (vi) Biswajit Chakrobarty (19 Yrs) S/O-Sujit Chakrobarty of Fulbari, Chuna Vati near Football Ground, PS-NJP, Dist-Jalpaiguri, (vii) Krishna Debnath (20 Yrs) S/O-Sujit Debnath of Shree Nagar Colony, Back Side of Uttar Kannya, PS-NJP, Dist-jalpaiguri, (viii) Debasish Saha (30 Yrs) S/O-Lt. Netai Ch. Saha of Surya Sen Colony, RLY Hospital More, PS-NJP, Dist- Jalpaiguri and (ix) Akash Sarkar (22 Yrs) S/O-Lt. Ram Sarkar of Noukaghat near Medical College, PS-Matigara, Dist-Darjeeling. I, SI Malay Kr. Roy of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 02.08.2021 at around 11.50 hrs during my R/T Mobile Van duty, myself along with my accompanied force had been to Venus More, Siliguri and found that the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before Police that, they were well aware of the pandemic situation and all the orders of Government as well as local administrations regarding COVID-19.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021, 753/II-ISS/2M-22/2020 dated 28.06.2021, 753/III-ISS/2M-22/2020 dated 14.07.2021 and 753/IV-ISS/2M-22/2020 dated 29.07.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the State as well as country. According, I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270-IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
