I SI Ashim Kr Das of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 03.08.2021 at about 21:35 hrs while performing special raid duty at Panitanki More and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Bijay Kumar (22) S/O Bikhari Sha of Lakhi Colony, Ward No. 44, PS- Bhaktinagar, Dist- Jalpaiguri (2) Sohel Aktar Rana (23) S/O Iuchhaph Ali, of Shibeswar, Rangpur, PS- Dinhata, Dist- Cooch Behar (3) Prasan Kumar Dhar (45) S/O Lt. Pradip Kumar Dhar of New Milanpally, PS- Siliguri, Dist- Darjeeling (4) Bapi Roy (20) S/O Sukhnath Roy of Bhupendra Nagar, Behind Vega Circle Mall, Ward No. 42, PS- Bhaktinagar, Dist- Jalpaiguri (5) Samiran Das (45) S/O Nishi Kanta Das of West Bhaktinagar, Ward No. 34, PS- Bhaktinagar, Dist- Jalpaiguri (6) Raja Gupta (45) S/O Nirmal Kr Gupta of South Bharat Nagar, Ward No. 24, PS- Siliguri, Dist- Darjeeling (7) Achinta Sarkar (49) S/O Lt. On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and night curfew period. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any disease dangerous to life during Pandemic disaster situation and night curfew period.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/III-ISS/2M-22/2020 and order No-753/II-ISS/2M-22/2020 dated 28/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.
