With due respect, I ASI Subodh Ch. Biswas of Matigara P.S SPC would like to lodge this written complaint against Manojit Sarkar, Kharganath Barman, Sujan Roy, Lipika Barman and others 10/12 approx to the effect that today i.e 20.07.2021 at around 13.25 hrs in course of Mobile Van duty vide Matigara PS GDE No. 1122, Dated- 20.07.2021 and MCC No. 1340/21, Dated - 20.07.2021 received information that some people put a road blocked on National Highway -31 at near NBU gate No-2, Shivmandir under P.S - Matigara, Dist - Darjeeling. Accordingly, I along with my accompanied force had been to near NBU gate No-2, Shivmandir under P.S - Matigara, Dist - Darjeeling and found approx 10/12 persons under the leadership of above noted Manojit Sarkar, Kharganath Barman, Sujan Roy, Lipika Barman have obstructed the National Highway. for their various demands. However after prolonged talking with them they were made understood and subsequently withdrew the blockade at around 14.05 hrs.

Under the above circumstances, I pray before your good office that a specific case under proper section of law may kindly be initiated against above noted Manojit Sarkar, Kharganath Barman, Sujan Roy, Lipika Barman and 10/12 others and arrange for its investigation.
