Respected Sir,

With due respect I Smt. Sukanya Das, Wife of Sri Koushik Das, resident of C/o Sri Sachin Das, South Babupara, Siliguri, would like to inform you that on 4<sup>th</sup> April, 2021 I have received a friend request on Facebook from one Arnab Ghosh and at about 11:30 p.m. I have accepted the friend request of him and said Arnab Ghosh started messaging me on messenger and he had sent me his Whatsapp number and told me to make conversation over Whatsapp and I did it accordingly as before he send me his Whatsapp number i.e. 8910854388 over messenger and he told me about my husband that he knows him very well and also told me about my husband's job and he also told me that he also works in State Bank of India in the same Branch where my husband is posted but he is basically from Siliguri as per his version and so I met conversation with him over Whatsapp and at about 1:11 a.m. he told me that he will do video call and accordingly he did it.

Sir, then over the video call I was unable to see him as the other side was totally dark and I literally told him that I cannot see him then said Arnab Ghosh told me that due to load shedding there was no electricity and we talked over some lame issues then he showed me a place over the video call where a fire was ablaze and then I asked him about what it is, he told me that Shiv Puja is going on and I saw another person is chanting mantra and then he told me that after seeing the fire I will go mad then all of a sudden I felt like I am under his influence and control and then he told me to do some indecent thing and I did it without knowing that he is recording it from the

other side and then he hang up the video call. It is to be mentioned that from the very next date he started sending me messages through messenger, Whatsapp and text messages and did it repeatedly with some double meaning messages which indicates something vulgar and when I told him not to send messages as I feel awkward then he told me that, he have something recorded from that video call and if I do not entertain him over telephone then he will spread it over internet and also show it to my husband and started blackmailing me then ultimately finding no other alternative on 30<sup>th</sup> day of April, 2021 I blocked him from Facebook, Whatsapp and other communication over telephone then he call me several times but as it was block I did not receive it.

Sir, I further want to inform you that on 28<sup>th</sup> July, 2021 at about 2:30 p.m. my husband Sri Koushik Das received messages from said Arnab Ghosh over Facebook and told my husband to see a video and then he send / transmit the indecent video of mine to my husband on his messenger and from then certain dispute has arise in between me and my husband.

So I therefore apprehend that if he can send / transmit the video of mine to my husband then he might have transmitted the video over internet which was recorded without my consent and as such I therefore request you and your good office to initiate a specific case against said Arnab Ghosh for recording my indecent video without my consent and transmitting it to others.
