In producing herewith 03 (three) arrested accused persons who disclosed their identity as (i) No. Raja (27 yrs), s/o - Md. Basir of Ashraf Nagar, Maszid Para, PS- Bhaktinagar, Dist - Jalpaiguri (ii) Manab Roy (20 yrs), s/o - Sunil Roy of Uttar Saripakhar, PS- Malbazar, Dist - Jalpaiguri (iii) Tapash Roy (26 yrs), s/o - Manju Roy of Panga Battala, PO- Karjipara, PS- Kotwali, Dist - Jalpaiguri.

I, ASI Diapak Singha of Milanpally OP under NJP PS /SPC do here by lodge this written complaint against the above noted persons to the effect that while on performing Naka duty myself along with officer and forces had been to Teesta Barrage under Milanpally OP at 22.35 hrs and after that found the above noted persons are moving there without any reason and found them without wearing mask. Thereby making unnecessary gathering at Teesta Barrage under Milanpally OP. On being asked the above noted persons stated before me that they were well aware of Govt Order regarding pandemic situation of Covid 19 and wearing of facial mask has been mandatory in public places in the current pandemic disaster situation.

They all violated the order of Govt. of West Bengal vide Memo No - 486-CS/2021, Dated - 24/04/2021 & Govt Order No - 647-ISS/2M-22/2021, Dated - 15.05.21. Hence I arrested them u/s - 41 Cr.P.C in c/w the case under proper memo of arrest duly signed by them in presence of witnesses and lodge a FIR against the above noted three persons at 00.05 hrs at Milanpally OP under NJP PS/SPC.

Now I request you for starting a specific case U/S-188/269/270 IPC r/w Sec 51(b) of Disaster Management Act 2005 against the above noted accused persons and arrange proper investigation of the case.
