Rabi Tamang of Ambari Falakata OP under NJP PS/SPC beg to report that on 30.07.21 in course of mobile van duty vide Ambari OP GDE No- 1052 dated on 30.07.21 myself along with force namely (1) ASI. Biswajit Ghosh and (2) Jamirul Haque and (3) NVF/131 Bidhan Roy all of Ambari-Falakata OP, Under NJP PS/SPC had been to Nawapara More, under Ambari Falakata OP. PS. NJP to perform mobile Van duty at 18:35hrs I found the above noted persons were roaming without face mask at that area and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Hence I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.
