Respected Sir,

My daughter Sakuntala Singha got married with Bankim Singha Son of Mahanta Singha resident of Fairanjote, P.O. Ranidanga, P.S. Matigara, Dist. Darjeeling in the year 2016. After a month of a marriage, Bankim Singha, his mother Smt. Lalita Singha, his father Mahanta Singha, his uncle Jayanta Singha, his aunt Jayanti Singha, his paternal grand mother Smt. Bajari Singha, his brother Biswajit Singha, Surajit Singha, Harosunder Singha began harassing her. Her mother in law demanded a dowry of Rs 1,00,000/- (One Lakh) after marriage. I was unable to pay that amount.

One and half month before Bankim Singha and above named accused persons severely beaten my daughter Sakuntala. We called meeting of neighbors' at Fairanjote for a compromise. Bankim Singha and other accused persons promised not repeat it again. The harassment and beating was frequent.

On 3rd July, my daughter phoned me from her phone that her husband and her relatives i.e accused persons above named are torture him, I phoned her and come to know that Bankim Singha and above named accused persons was threatening to kill her and to got second marriage. He has a extra martial relation with another girl.

On 4th July, my daughter phoned her mother and said that save me, Bankim and other accused persons is threatening me kill and is beating me. And my daughter throw out from her her husband's house, now she is living my house at Nehalu Jote, P.O. Nema, P.S. Matigara, Dist. Darjeeling with her baby.
