th producing herewith six (06) arrested accused persons namely (i) Nehar Das (18), S/O-Deb Das of Kawakhali Bazar, PS- Matigara, Dist- Darjeeling, (ii) Shibu Debnath (23), S/O- Apu Debnath of Medical Kawakhali, PS- Matigara, Dist- Darjeeling, (iii) Bhawesh Roy (19), S/O-Bijoy Roy of Matigara Bazar, PS- Matigara, Dist- Darjeeling, (iv) Mangal Sahani (32), S/O- Lt. Ram Dulal Sahani of Matigara Bazar, PS- Matigara, Dist- Darjeeling, (v) Md. Maibul Islam (38), S/O- Md. Hazrat Islam of Moynaguri, PS- Moynaguri, Dist- Jalpaiguri and (vi) Pinku Roy (28), S/O- Lt. I, PSI-Abhishek Theengh (32), S/O-S.K. Theengh of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Nehar Das, (ii) Shibu Debnath, (iii) Bhawesh Roy, (iv) Mangal Sahani, (v) Md. Maibul Islam, (vi) Pinku Roy and (vii) Avishek Minj, (viii) Md. Sagar, (ix) Debu and others to the effect that today on 07.08.2021 at 00.15 hrs received a sources information that 10/12 youths have assembled at behind Bhangapul, Himul under Matigara PS with a view to commit docoity at that area. The fact was diarized in GDE vide Matigara PS GDE No-361 dated 07.08.2021. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Tapan Das, ASI Nitai Ch. Mandal, C/986 Rajib Sarkar, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information.

At about 00.35 hrs after reaching near Bhangapul, Himul PS- Matigara I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence: But, seeing the police party approaching towards them they tried to flee away from the spot. But, on hot chase we managed to apprehend above hoted six (06) accused persons namely Neharl Das, Shibu Debnath, Bhawesh Roy, Mangal Sahani, Md. Matibul Islam and Pinku Roy along with seized articles from their possession as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Bhangapul, Himul area.

I thereafter, seized the above noted weapons under proper seizure in presence of witnesses and being acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.25 hrs, Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the name of arrest to them.

If accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Bhangapul, Hiul area. It is also revealed from them that Avishek Minj, Md. |Sagar, Debu and some others have assembled there with them and planned for committing the dacoity.
