They all are violated the order of Govt. of West Bengal vide Memo No. 486-CS/2021 dt. 24.04.2021. Hence, I arrested them in c/w the case under proper memo of arrest in between 21:20 Hrs and 22:05 hrs duly signed by them in presence of witnesses inform the ground of arrest.


