Sir,

This is to inform you that yesterday dated 06/08/2021, Friday, time approximate 23:30 hours a terrible theft and mess occurred at SI/S Siliguri West Circle at BDO Office Campus , Matigara.

After careful investigation it is found all the water tap and water connection of three toilets and three basin has been broken and stolen from the office. All the lock of Almirah has been broken and the all important financial documents, cheque books are spread on the floor. The three locks of three different gates are broken by the thefts for entering in the office!

It is also found that the office ground floor arena is fully blooded. It may be happened by the wounded theft at the time of breaking of the water basin.

This incident makes a fear and tension among the whole office staffs.

Hence, you are requested to take necessary action from your end about this matter.
