Sir,

In producing here with the accused person namely Janaki Paswan (58/F) W/O Late Shiv Narayan Paswan of Ganganagar near river side, ward No.05, PS- Siliguri, Dist- Darjeeling along with seized 15 (fifteen) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/-in each bottle i.e. total amount of Rs- 1500/- (Rs/- one thousand five hundred) in which 01 (one) bottle taken as sample and marked as Exhibit-"A-1".

I ASI Niranjan Sarkar of Khalpara TOP under PS Siliguri beg to report that today i.e. on 06.08.21 while performing special mobile van raid at 13:55 hrs I received a source information that one person namely Janaki Paswan (58/F) W/O Late Shiv Narayan Paswan of Ganganagar near river side, ward No.05, PS- Siliguri, Dist- Darjeeling is selling huge alcohol at Ganganagar near river side under Khalpara TOP without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force with lady force left for Ganganagar near river side area, Siliguri to verify the veracity of the information vide Khalpara TOP GDE No - 183, Dated: 06.08.21. After reaching Ganganagar near river side at 14 25 hrs and as shown by the source I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept her. On being asked she disclosed her identity as mentioned above. During search, I could recover the above noted alcohol from her house. During interrogation she admitted that she is selling alcohol for her wrongful gain. On demand she failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses namely I) L/C 1216 Puspanjali Yanjan of Khalpara TOP II) Md, Islam(45/M) S/O Late Md. Daud of Santoshi Nagar, near Ram Janki Mandir, ward no- 5, PS- Siliguri, Dist- Darjeeling and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest.
