They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation

and night curfew period.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/III-ISS/2M-22/2020 and order No-753/II-ISS/2M-22/2020 dated 28/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accounding I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Navneet Agarwal (36) S/O Mahesh Agarwal (2) Ranju Ghosh (34) S/O Bhupendranath Ghosh, (3) Md.
