In producing herewith 01 (One) arrested accused person namely Rahil Khan (30 yrs) S/O Rust on Khan of Vill- Ramgarh, Teh- Ramgarh, PS- Ramgarh, Dist.- Aluwar, Rajasthan and tollowers articles under seizure viz:

1) One Truck displaying number plate HR/74/4228 loaded with Teak timber total 56 loges (measurement mentioned in seizure list)

1 SI Coutam Mallik of NJP PS, SPC do hereby lodge this complaint against the above noted arrested accused person that today (08.08.21) at about 14.15 .hrs I received a source information that one truck displaying number plate HR/74/4228 is coming from Assam side towards Bihar which is loaded with huge quantity of stolen timber (Teak logs). Accordingly, I informed the fact to you and diarised the fact in General diary vide NJP PS GDE No 394 dated 08.08.21 and as per your kind direction myself along with ASI Khagen Barman, C/1053 Paresh Rava, VP/08 Laxman Roy, VP/13 Jamirul Islam CV/306 Biswajit Roy left for Jatikali More to verify the veracity of the information. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender: In the mean time I called two independent witnesses namely (I) Gopal Dhar S/O Kamal Dhar of Ambikanagar, PS-NJP, Dist. Jalpaiguri and (2) Subhojit Sen S/O Subir Sen of Shaktigarh, Road No-06, PS-NJP, Dist. Jalapiguri and informed them about the information in hand and requested them to remain present with us as witness during the search and seizure if necessary and in which they agreed. At 14.45 hrs we arrived at Janakali More, and at 15.05, hrs we managed to intercept the said truck displaying number plate HR/74/4228 at Jatiakali under NJP PS and found one person seating in the driver seat of the said vehicle. On interrogation he disclosed his identity as noted above. Subsequently, we searched the vehicles and found huge number of Teak log loaded in the said vehicle. On counting it is found that the vehicle loaded with total 56 (Fifty six) numbers of loges of tick timber measuring approx total 559.47 CFT.

On demand the above noted accused person failed to produce any valid documents in respect of the above noted Teak logs loaded in his vehicle as well as failed to produce any documents in respect of the vehicle. Being further interrogated he disclosed that he in connivance with others and after getting permission of the truck owner he have procured the teak logs clandestinely from Assam by illegal way with a view to sell the same in Kolkata for their personal gain.
