Finding no any other alternative I arrested them u/s 41 Cr.p.C under proper memo of arrest after explaining the charge against them.

Under the above circumstance I request you that a specific case may kindly be started U/S 188/269/270 IPC R/W Sec 51(b) Disaster Management Act. 2005 against the above noted 11 (Eleven) arrested accused persons and arranged proper investigation of the case.
