Subject: Complaint against my husband Sri Mohit Saraf, My Father in-Law Sri Ramesh Saraf and My Mother-in-Law Smt. Manju Saraf for commission of mental and physical torture and cruelty upon me.

Sir,

I, Smt. Sweta Agarwal, Daughter of Sri Purushottam Lal Agarwal, Resident of Green View Apartment, Upper Bhanu Nagar, Sevoke Road, P.O. Sevoke Road, P.S. Bhaktinagar, District - Jalpaiguri, would like to inform you about the heinous crimes committed upon me by My Husband Sri Mohit Saraf, My Father-in-Law Sri Ramesh Saraf and My Mother-in-Law Smt. Manju Saraf. I was married to Sri Mohit Saraf on 09.02.2020 at Hotel Clarks Amer, Jaipur, Rajasthan as per Hindu rites and customs. At the time of my marriage, my father gave huge amount of cash and other gold, diamond and valuable items and articles as was demanded by my husband and my in-laws and as per the demand of my husband and my in-laws Rs. 11,00,000/- (Rupees Eleven Lacs) only which was transferred to Mr. Murli Agarwal (Phone No. 99209-15608) and Mrs. Seema Agarwal (Phone No. 99209-15093), the relatives of my husband and sum of rupees Rs. 10,00,000/- (Rupees Ten Lacs) only was also paid to Mr. Anil Mohta (Phone No. 93140-21355) at Jaipur. My father gave a total sum of Rs. 24,65,000/- (Rupees Twenty Four Lakhs Sixty Five Thousand) only is cash as dowry amount to my husband and in-laws as per their demand and also incurred all the expenses of marriage ceremony to the tune of Rs. 10 to 11 Lacs. After the marital ceremonies were over I was taken to my matrimonial home situated at Ward No. 18, Sarafo ka Mohalla, Hanumangarh Town, Hanumangarh, Rajasthan. There were several facts that were kept away from me at the time of wedding which I slowly discovered. Since the day of our marriage I have never slept at peace. My husband and my in-laws all tortured me mentally and physically every day.My in-laws always used to tell me that if they would have got their son married with another girl of their caste they would have got Rs. 1,00,00,000/- (One Crore) only as dowry.

My husband was posted at IIT Kanpur as Project Scientist where I accompanied my husband during the 1st week of March, 2020. I hoped the relationship with my husband would gradually develop, but to the contrary

it got worse. We stayed in a rented flat at Kanpur with no amenities. My husband started treating me like a maid servant and used to abuse me and my family members every day and night. I was forced to do each and every household work by my husband and I was even not provided with a single penny for my personal expenses. It is pertinent to state here that before the marriage it was told to me by my Husband and in-laws that my husband earns a handsome salary of Rs. 1,00,000/- (One Lakh) only per month on believing which I gave my consent to marry but when we shifted to Kanpur I got to know that the actual salary of my husband was only Rs. 40,000/- and my husband and in-laws has defrauded me with a blatant lie and fraudulently obtained my consent to the marriage.

I am an educated lady and it was agreed by my husband before marriage that I would be allowed to continue my job after marriage but after marriage I was not allowed to do job by my husband and in-laws and on contrary I was asked to do each and every household works and was treated no less than a maid servant. I was forced to cook food in a broken LPG Gas stove which was quite a hazard as with a risk of fire injury inspite of several persuasions my husband was not convinced to replace the same inspite of the same could lead to death. My personal liberty was curtailed by my husband and I was mentally and physically tortured by him at Kanpur. During the stay at Kanpur he always behaved with me like he is my boss and I am his servant. After these incidents I suffered from PCOD disease and my husband did not care to take me to doctor or get medicine for the same and on the contrary my husband asked me to leave the house or to ask my parents to send the expenses for my treatment. My husband always tortured me for money and on many occasions he forced me to get money from my parents and my parents on numerous occasions transferred money in to my account for my food and household expenses.

During my stay at Kanpur he used to come home late at night in a drunken condition and used to abuse me with filthy words and on one occasion he even physically assaulted me with fists and blows.

The greed of my husband and my in-laws is a never ending one and whenever I went to my matrimonial house at Hanumangarh I was forced to ask money from my father. They always had a demanding attitude and when I said that I can't ask for money every then and now from my parents then they used to behave in an outrageous manner and started taunting me with words like short heighted and ugly girl and that my husband has married with me only for money and no one likes me. I looking into the old age and ailing health of my father, used to tolerate all the mental and physical tortures of my husband and in-laws. Quete Garing

In the month of March, 2021 my father had a heart surgery at Bangalore and on 6th March, 2021 I went to Bangalore for taking care of my father and since then my husband did not care to console me. Only once in 3th April, 2021 he came to Siliguri at our house as per the request of my ailing father and left on 5th of April, 2021 and in the said visit he physically assaulted me in front of my father and mother and abused my father with filthy words. My husband taking advantage of the surgery of my father without informing me he went to USA on the 14th April, 2021 and at present he is working in Drexel University at USA Philadelphia as because at that relevant point of time I was not in a frame of mind to leave my parents and travel abroad.

Since then several communications were made with my husband but inspite of the same he refused to provide any assistance so that I can travel to The United State of America and stay with my husband. My Father inspite of rude and reckless behaviour in the part of my husband and my in-laws, inspite of his ill health he took the pain to travel to Hanumangarh with me and my mother and brother on 7th July, 2021 and tried to amicably settle the dispute in between us but my in-laws were not in the frame of mind and was quite stubborn to end my marital tie with his son.

Finding no other alternatives and considering the health of my father I decided not to proceed further with these issues as because my father is the patient of cardiac disorder and any stress whatsoever can take away his life and considering this fact I decided to take back my articles lying with my inlaws and amicable end of the marital tie with my husband. My in-laws promised to pay back the amount of Rs. 24,65,000/- (Rupees Twenty Four Lacs Sixty Five Thousand) only which they took as the dowry within one month but unfortunately they did not keep their promise at present I am staying at my parental house at Green View Apartment, Upper Bhanu Nagar, Sevoke Road, P.O. Sevoke Road, P.S. Bhaktinagar, District-Jalpaiguri and is passing days through hardship, my father and my brother are maintaining me.

Now I have finally decided to avail the remedies provided under Law and I lodge this complaint before you with hope of getting justice.

I humbly request to kindly enquire into the matter and initiate appropriate actions against the abovenamed persons for the ends of justice.
