I, SI Partha Sarathi Das of OC Ashighar OP under Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that today on 07.08.2021 at 22.05 hrs U.S 399/402 received a sources information that 11/12 youths have assembled the riverbed of Farabari Forest with a view to commit dacoity in a house at Ashighar area. The fact was diarized in GD vide Ashighar OP GDE No- 182 dated 07.08.2021, Subsequently after sharing the information with my superiors and as per their direction, myself along with force of Ashighar OP left for the place to work out the information . We reached at near riverbed at 22.20 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was Inspectal in committee to the seeing police personnel. They tried to flee away but on Bhaktinagar Police we managed to apprehend about 10 to 10 Bhaktinagar roma to flee away but on spiral Police Committee accused persons along with spiguit Police Committee accused persons along with away from the spot taking the advantage of darkness. On interrogation the accused person admitted that they had assembled there to commit dacoity in a house at Ashighar area.
