I, Hem Maya Chettri w/o Rajesh Sharma, in-law resident of
Durga Nagar, S.M.C Ward No-40, want to inform you that from last few
months my husband "Rajesh Sharma" and brother-in-law "Braj Kishor Sharma"
have been creating massive chaos by assaulting me and my Sister-in-law
'Jinnat Kalandri' both physically and mentally.

Both Rajesh and Braj have been coming everyday late at
night in an intoxicated condition and involving torturing me and my
Sister-in-law.

Today at 14:00 a.m, 8/8/2021, Rajesh started abusing me brutally
with fists, blows and kicks. Also trying to strangle me with 'Kupetta'
when my father-in-law, Mother-in-law and my youngest brother-in-law
intervened to stop him from abusing me, Rajesh attacked my father-in-law
(Ram Kisan Sharma) trying to stab with a sharp knife. Braj also joined him
and started assaulting Jinnat (His wife) and my father-in-law.
I somehow managed to save myself and rest of the family with
the help of local people. Meantime, Police were called and both Rajesh
and Braj are now in Police custody. Moreover, they have started to threaten
to throw my Parents-in-law from the house and our own property.

Hence, I kindly request you to take a necessary step as soon as
possible as I and my family are facing great difficulty and mental
agony. If appropriate actions are not taken against Rajesh and Braj, anything
worse may happen to our life and as I have been threatened to be killed
as they get a chance.
