Sir,

In producing herewith one accused person namely Rohit Roy-40yrs s/o Lt Bablu Roy of Kamalanagar, Salugara, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 03 (Three) Bottles of Kalyani Black Label strong Beer (each bottle containing 650ML & in each bottle mentioning M.R.P of Rs- 120/-in each bottle i.e. total amount of Rs- 360/- (Three hundred sixty only)
2. 09 (Nine) no's of pet Bottles of Himalayan Gold 60up country spirit (each bottle containing 600ML in each bottle mentioning M.R.P of Rs- 100/-in each bottle i.e. total amount of Rs- 900/- (Nine hundred only)
3. 01(One) no's of pet Bottle of Boss 60up country spirit containing 600ML & MRP Rs-100/- only
4. 01(One) Bottles of Kingfisher strong premium Beer containing 650ML & MRP Rs-120/-)

All the articles packed in one big nylon bag.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Rohit Roy-40yrs s/o Lt Bablu Roy of Kamalanagar, Salugara, PS Bhaktinagar Dist Jalpaiguri to the effect that on 08.08.21 at 18.20 hrs received a source information from Kamalanagar under Bhaktinagar PS that one person namely Rohit Roy of that locality gathered huge quantity of liquor in his house for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-442 dated 08.08.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 18.50 hrs we reached at the spot, sometimes after being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 19.20hrs to 20.10hrs)

I therefore request you a specific case may kindly be started against the accused person namely Rohit Roy-40yrs s/o Lt Bablu Roy of Kamalanagar, Salugara, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
