With due respect, I, SRI SUBHAJIT SAHA, Son of Sri Respected Sir, Shyamal Saha of Near Niranjan Nagar, Yabak Sangha, Ghogomali Main Road, Ward No. 37 of SMC., Siliguri, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri would like to lodge this written complaint to the effect that I am a Government Contactor and I have been working in the said line since last 3 years with sincerity and honesty and out of my small income from my said work, I used to maintain myself as well as my family members. It is to be mentioned here that since in the first part of 2020, myself and my family members have decided and intends to purchase a four wheeler vehicle for our personal use and for the purpose of purchasing a four wheeler vehicle, I along with my father and younger brother have visited the showroom of Lexicon Motors, Reliance Industrial Consortium Ltd., at Kushum Nagar, Matigara where we met with the Sales Representative Sri Tapan Nandi and the Manager Sri Vishal Sulekha and after thorough discussion with them, we have decided to purchase a fourwheeler vehicle of ALTROZ XZ (O), which is the highest model of Tata Motors as on the day of our visit i.e. in the month of June, 2020 and the Ex-Showroom price of the said vehicle was Rs. 7,69,000/- only and on road price of the said vehicle was Rs. 8,71,905/- only and after discussion with them, I have decided to purchase the said vehicle namely ALTROZ XZ (O) and accordingly, I have paid and deposited a sum of Rs. 21,000/- only by way of Account Payee Cheque being Cheque No. 023151 in favour of Lexicon Motors, Proprietor of Reliance Industrial Consortium Ltd., Matigara as advance and the said cheque was cleared on 08.07.2020 and they have also assured me that if I booked the said vehicle on that day through cheque, they will provide/give a discount of Rs. 31,905/- only from the total amount of the on road price of the said vehicle and also induced me that they will deliver the said vehicle in my favour within a period of one month from the date of booking and on being induced by them, I have deposited and handover the said cheque of Rs. 21,000/- only in their favour. Thereafter, I have applied loan for

purchasing the said vehicle from the Central Bank of India, NJP Branch, Bhaktinagar and accordingly, the Central Bank of India granted loan in my favour for purchasing the said vehicle. Thereafter, the authority of Lexicon Motors, Reliance Industrial Consortium Ltd. informed me that the vehicle is ready to deliver and asked me to deposit the remaining amount and accordingly, on 04.08.2020, I have paid and transferred the quotation amount of Rs. 8,71,905/- only to the Lexicon Motors, Reliance Industrial Consortium Ltd. through RTGS and on 06.08.2020, the Lexicon Motors, Reliance Industrial Consortium Ltd. and after receiving the said amount, they told me that they will transfer the amount of discount and the advance amount in total of Rs. 52,905/- only in my favour through the Account Payee Cheque but they returned back a sum of Rs. 50,857/only instead of the amount of Rs. 52,905/- only. After receiving the entire quotation amount against the delivery of vehicle Tata ALTROZ XZ (O) BS-VI, they have delivered the vehicle believing me to be the said ATROZ XZ(O) BS - VI Model vehicle for which I have delivered the amount as per the quotation and after receiving the vehicle from the Lexicon Motors, Reliance Industrial Consortium Ltd. I have parked and kept the vehicle in our house and after bringing the said vehicle, I found that the vehicle and noticed being Chassis No. MAT632115LPGG4210 and Engine No. REVTRN10GZXM03870 is of the description of ALTROZ XZ and not ALTROZ XZ (O) as mentioned in the Tax invoice being No. SG/CBI/087/2021, Dated: 06.08.2020 and also found that the entire roof and the metal portion above the left front wheel of the said vehicle is repaired and repainted and the TATA ALTROZ XZ is a low model vehicle with ex showroom price of Rs. 7,44,000/- only compared to TATA ALTROZ XZ (O) which is a high model vehicle with ex showroom price of Rs. 7,69,000/- only as per the price list as on dated 01.06.2020. Thereafter, I have contacted with the Officials and Manager and other Representatives of Lexicon Motors, Reliance Industrial Consortium Ltd. and told them that they have supplied me low model vehicle and repaired and repainted vehicle instead of brand new TATA ALTROZ XZ (O) vehicle even after receiving the amount against the delivery of TATA ALTROZ XZ (O) vehicle and thereby, all the Officials, Manager and Representatives of the Lexicon Motors, Reliance Industrial Consortium Ltd. have in conspiracy with each other have supplied a low model TATA ALTROZ XZ vehicle instead of TATA ALTROZ XZ (O) vehicle and I have requested them to supply me a new TATA ALTROZ XZ (O) vehicle or to refund the entrusted amount against the quotation to of the said

vehicle which they have received from me and hearing the same, they have admitted the said facts and told me that due to some technical mistake, they have delivered the low model vehicle instead of the TATA ALTROZ XZ (O) vehicle and they assured me that within a very short period, they will replace the said vehicle and deliver a new vehicle of TATA ALTROZ XZ (O) model instead of the TATA ALTROZ XZ model vehicle as no stock is available in their showroom and after receiving such type of assurance from them, I have waited for the same but after lapse of time, when they have failed to deliver the ALTORZ XZ(O) vehicle, I again visited in their showroom and requested them to deliver the actual vehicle in my favour after replacing the low model vehicle but neither they replace the said vehicle nor they return back the entrusted amount which they have received from me against the delivery of TATA ALTROZ XZ (O) vehicle and thereby, all the Officials, Manager and Representatives and others of the Lexicon Motors, Reliance Industrial Consortium Ltd., in conspiracy with each other have induced me to entrust money to them against the delivery of TATA ALTROZ XZ (O) vehicle and even after receiving the amount as per the quotation amount against the delivery of TATA ALTROZ XZ (O) vehicle, they have delivered low model vehicle of TATA ALTROZ XZ repaired and repainted vehicle intentionally with an intention to misappropriate the amount and also deceived to cheated me and to that effect, they have prepared some forged documents and used the same as genuine knowingfully well that the same are forged. Finding no other alternative, I have sent a legal notice to the Proprietor and other officials of Lexicon Motors, Reliance Industrial Consortium Ltd., through my engaged lawyer Mr. Manojit Roy on 18.12.2020 and they have received the said notice but inspite of receiving the said notice, neither they return back the entrusted amount nor they replace the said vehicle.

I, therefore, request you to kindly investigate into the matter and please take necessary legal steps against the Proprietor Sri Vishal Sulekha and other officials of Lexicon Motors, Reliance Industrial Consortium Ltd., as per the provision of law and obliged thereby.
