In producing herewith two accused persons namely (i) Shital Kr. Roy (36) s/o Lt. Ramdas Roy of B-72, Basundhara Abasan, PS New Jalpaiguri, Dist. Jalpaiguri along with the following seized articles under seizure as per seizure list:

- 1) One packet weight 20 kg 100 grams said to be Ganja wrapped by a brown colour Tape Marked as Exhibit "A"
- 2) One packet weight 20 kg 450 grams said to be Ganja wrapped by a brown colour Tape Marked as Exhibit "B"
- 3) One yellow colour plastic sack. Marked as Exhibit "C".
- 4) One yellow colour plastic sack. Marked as Exhibit "D".
- 5) One Supro Maxtruck T2, HD Series bearing Regt. No. WB73E 9681 Marked as Exhibit "E"

Exhibit "A" found inside Exhibit "C" and Exhibit "B" found inside Exhibit "D" from possession of Shital Kr. Roy s/o Lt. Ramdas Roy of B-72, Basundhara Abasan, PS New Jalpaiguri, Dist. Jalpaiguri who was carrying said to be Ganja in his vehicle noted above Marked as Exhibit "E".

Total weight of the said to be ganja (Exhibit A and Exhibit B,) is 40 Kgs 550 gms.

I, SI Gautam Laskar of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person to the effect that on today i.e 09.08.2021 at 14.05 hrs I received a specific source information that above noted accused person would be coming with his vehicle bearing Regt No. WB73E 9681 from Jalpaiguri side to NJP area with suspected consignment of Ganja procured from containing in his vehicle for disposing the same at New Jalpaiguri area. I accordingly shared the information through messenger to SI Samir Tamang, O/C New Jalpaiguri PS, Siliguri Police Commissionerate and as per his kind direction, diarized the fact in GD vide New Jalpaiguri PS GDE No 439 Dated 09.08.2021. Consequently, at 14.45 hrs, myself along with ASI Khagen Barman CV 824 Niru Kumar Yadav and CV 116 Rohit Mahato all left for Jotiyakali to verify the veracity of the information vide GDE No 439 dated 09.08.2021 by Govt. Vehicle taking necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 14.55 hrs we reached near Jotiyakali and parked the vehicle at considerable distance and proceeded towards Jotiyakali. Meanwhile, I called two disinterested witnesses namely 1) Sukamal Sengupta s/o Subir Sengupta of Shaktigar Road No. 3, PS NJP, Dist. Jalpaiguri, 2) Soumya Bikash Ghosh s/o Lt. mantu Ghosh of Purba Dhanntala, PS NJP, Dist. Jalpaiguri. I disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure, if any. Meanwhile, our Police party started looking for accused person and finally said vehicle reached at Jotiyakali, we signalled the said truck to stop but did not follow any signal and tried to flee away from that place. After hot chase Somehow we could managed to stop the said vehicle and detained the driver with a strong reason to believe that he carries illegal said to be Ganja in his vehicle and the secret source information seemed to be matched with appearance of said person. I disclosed our identity to him. On being asked he disclosed his name and address as noted above and also admitted that he is carrying contraband said to be Ganja in his vehicle. I, then, gave him option that whether he wanted to be searched in presence and supervision of Executive Magistrate or police Gazetted Officer. He agreed to be searched in presence of
