In producing herewith 05(Five) accused persons namely (1)Rabin Singh (24) S/Olt Ashok Singh, of Gurung Busty, Bhanu Bhakta Lane, Road no-3, Ward no. 03, PS- Pradhan Nagar, Darjeeling (2) Madhusudhan Paul (43) S/O Lt. Manatosh Chandra Paul, of East Vivakeanand Pally, Ward no. 38, PO. Rabinde Sarani, PS- Bhaktinagar, Dist- Jalpaiguri (3) Raj Kumar Saha (48) S/O Lt. Shita Nath Saha, of Vidya Chakra Colony, Ward no. 44, PS- Bhaktinagar, Jalpaiguri (4) Laxman Ray (38) S/O Jatin Chandra Ray of Vivake Anand Nagar, Salugara, Ward no. 42, PS- Bhaktinagar, Jalpaiguri (5) Bablu Mallick (54) S/O Bijoy Mallick of Hakim Para, Raja Ram Mohan Roy Road, Near Bonny Enterprise, Ward no. 12, PS- Siliguri, Darjeeling under arrest.

I, SI Arindam Chatterjee of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 09.08.2021 at about 21:25 hrs while performing night curfew raid duty at Panitanki More and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1)Rabin Singh (24) S/O Ashok Singh, of Gurung Busty, Bhanu Bhakta Lane, Road no-3, Ward no. 03, PS- Pradhan Nagar, Darjeeling (2) Madhusudhan Paul (43) S/O Lt. Manatosh Chandra Paul, of East Vivakeanand Pally, Ward no. 38, P.O. Rabinde Sarani, PS- Bhaktinagar, Dist- Jalpaiguri (3) Raj Kumar Saha (48) S/O Lt. Shita Nath Saha, of Vidya Chakra Colony, Ward no. 44, PS- Bhaktinagar, Jalpaiguri (4) Laxman Ray (38) S/O Jatin Chandra Ray of Vivake Anand Nagar, Salugara, Ward no. 42, PS- Bhaktinagar, Jalpaiguri (5) Bablu Mallick (54) S/O Bijoy Mallick of Hakim Para, Raja Ram Mohan Roy Road, Near Bonny Enterprise, Ward no. 12, PS- Siliguri, Darjeeling

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation. Finding no other alternative, I arrested them U/S 41 Cr. P. C. as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any disease dangerous to life during Pandemic disaster situation.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/III-SS/2M-22/2020 and order No-753/II-SS/2M-22/2020 dated 28/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According I arrested them u/s- 41 Cr.P.C. in view of the case after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1)Rabin Singh S/O Ashok Singh (2) Madhusudhan Paul S/O Lt. Manatosh Chandra Paul (3) Raj Kumar Saha S/O Lt. Shita Nath Saha (4) Laxman Ray S/O Jatin Chandra Ray (5) Bablu Mallick S/O Bijoy Mallick and arrange for its investigation.
