Respected Sir,

This is to bring to your kind notice that I, Parijat Mitra, s/o. Late Ramen Mitra, a resident of Deshbandhu Para, A.P.C. Sarani by lane, P.O. Siliguri Town, W.No. - 30. P.S. - Siliguri,

Today at about 3pm at Deshbandhupara, Bidyapith Road, Golden apartment, I was tremendously physically assaulted by Amal Nandy s/o. Late Rakhal Chandra Nandy. At about 3pm, I was going to visit my married elder sister Lopa Nandy w/o. Amal Nandy. I was talking to my elder sister standing outside her house because in the morning today, Amal Nandy called my mother on phone and threatened her too to return the money which one of my friend borrowed from Amal Nandy. And now, as my friend is not being able to return him (as much I know) due to this pandemic situation, Amal Nandy is now threatening my mother and me repeatedly. I told him several times that its not my business or I don't know ever to whom he gave money or not. But still, he keeps on threatening me everytime. Today I thought that I will complain this to my elder sister. Therefore, I went to her flat and called her outside to tell her everything. Suddenly Amal Nandy came from behind and started beating me. I tried to save myself. He then became more ferocious and took up a cricket wicket in his hand and broke my right leg. Soon neighbours gathered and rescued me from his hand and I was carried to Siliguri District Hospital for immediate treatment. On such circumstances, I am really feared now because my life is in stake. I fervently request you to accept my complain and take necessary steps as early as possible. All medical copies are hereby attached for your kind perusal. Thanking You.
