I, Utpal Sarkar son of Late Ratan Sarkar, resident of Shanti Nagar, Bow Bazar, Siliguri, Ward No 36, Dist Jalpaiguri, Pin 734004 P.S. Bhaktinagar, I have my Relaince Resque Service Center in M.N.Sarkar Road, Chanapatty, Near Sovraj Hotel, Siliguri, Pin 734001 under Siliguri Police Station. Today 11th of August 2021 around 4.30 pm I was standing in front of my Office when I noticed few unidentified people around my scooter and one of them was sitting on my scooter trying to fiddle with the wires and the accelerator while others were crowding my scooter. Sensing some wrong intuitions, I politely asked them to move away. Suddenly they started to misbehave with me and used lot of abusive words. I grabbed one of them and asked my office staff to inform the Police. Then one of them started to use abusive words and the other guy hit me on my face. With in no time around ten to twelve people from their group arrived including some ladies. Then they grabbed me and hit me from all sides on my head, face and other parts on my body due to which I have got injuries and cut on my face and head.

I realized that they were anti socials and might be carrying arms with them which could had been more harmful for me if they had used it. By that time lot of local people had gathered and the accused people fled away. After the incident I realized that my wallet which had some important papers and around five thousand rupees along with my gold chain weighing around 18 grams was missing. Later few of those anti socials were identified as follows.

- 1) Sabana Khatun
Wife of Md Nazrul.

2) Md Sayed aged around 22 years.

Son of Md Nazrul

Both are resident of Coal Depot, Near Madrasa, Ward no 7, P.S Siliguri, Darjeeling.
While others (5 or 6) could not get identified.

I can identify the accused if arrested and give my statement. Some photographs and videos are there of the incident which can be helpful to identify the accused group of people.

Kindly take necessary actions against them to the earliest.
