Sir,

In producing herewith arrested two arrested accused persons namely (1) Barun Roy -30yrs s/o Lt Tarun Roy of Bholanathpara, PS Bhaktinagar Dist Jalpaiguri (2) Munna Karmakar-30yrs s/o Lt Ranjan Karmakar of Sastrinagar, Near Tiranga More, ward no-41, PS Bhaktinagar Dist Jalpaiguri under proper memo of arrest along with seized articles viz;

1. Four packets of SP-VON capsules each packet containing 6X3X8= 144pcs total (144X4) =576 pcs (among which three strips containing 3X8=24 pcs taken as sample) marked as Ex-A and Ex-A1 respectively) from the possession of Accused Barun Roy.
2. Two packets of Winspasma Forte capsules each packet containing 10X10=100 pcs total (2X100) =200 pcs (among which two strips containing 2X10=20 pcs taken as sample) marked as Ex-B and Ex-B1 respectively) from the possession of Accused Munna Karmakar.
3. One White colour Honda Activa scooty vide Registration No-WB74AP/3376
4. One mate Blue colour mi mobile phone vide IMEI No-868434043549387 & 868434043549395
5. One Samsung mobile vide IMEI No-353414106478742/01 & 353415106478749/01

I beg to report that on 09.08.21 at 20.05hrs, received source information that since few days the above noted persons and others are selling illegally procured spurious drugs in the house of accused Munna Karmakar at Sastrinagar, Near Tiranga More under Bhaktinagar PS to local peoples and others through one white colour scooty without valid license or documents and may be apprehended with such drugs, if responded immediately. Accordingly, the matter was diarised in General Dairy vide Bhaktinagar PS GDE no- 507 dated 09.08.21 and after informing your end and without making further delay I along with ASI Rabin Lama, C/374 Debraj Biswas, CVF/935 Bipal Roy and CVF/619 Dharmendra Roy all of Bhaktinagar PS rushed to the spot at PO vide GDE no-508 dated 09.08.21. Also, informed Drug controller Jalpaiguri, over telephone to be present at the spot but due to late night he failed to appear on the spot.

On the way, sought the service of the two persons namely (1) Giren Chandra Singh s/o Lt Bipadlal Singh of Samarnagar Bowbazar PS Bhaktinagar Dist Jalpaiguri & (2) Dipak Mondal s/o Rabindra Nath Mondal of Samarnagar Bowbazar PS Bhaktinagar Dist Jalpaiguri to stand as a witnesses during the search and seizure and arrest, if any. At 20.35 hrs, reached at the spot and contacted with the source and keeping the Govt vehicle at a distance started on foot. As pointed by the source, we cordoned the area in presence of the witnesses and managed to apprehend two male persons noted above and disclosed our identity as police personnel. Seeing Police party one Pappu of Iskcon Mandir road and one other fled away from the spot. On being asked, the persons disclosed their identities, as noted above. They also stated that Pappu and one another also

involved in this crime. Then, following all formalities, we conducted search of their persons and noticed the above noted drugs which were kept in the possession of accused persons could be recovered.

On interrogation, the apprehended persons in respect of such possession, they stated different statements at different interval of times, which had given rise to suspicion that they had procured the same illegally for their clandestine disposal. Further, on demand, they failed to produce any valid papers or documents in support of such possession of illegal capsules. Further, they admitted to have procured the said recovered drugs illegally for consuming them and peddling them to the drug addicts without any prescription.

Accordingly, after observing all formalities, I seized and labelled all the recovered drugs under proper seizure list and label duly signed by the witnesses and acknowledged by the accused persons and also, arrested the apprehended two above noted accused person's u/s 41 Crpc. All the formalities of seizure and arrest took place in between 21.05hrs to 22.10hrs.

Under the above circumstances, I pray before your kind end to start a case against all the above arrested accused persons namely (1) Barun Roy -30yrs s/o Lt Tarun Roy of Bholanathpara, PS Bhaktinagar Dist Jalpaiguri (2) Munna Karmakar-30yrs s/o Lt Ranjan Karmakar of Sastrinagar, Near Tiranga More, ward no-41, PS Bhaktinagar Dist Jalpaiguri also one Pappu of Iskcon road and one another under proper sections of law and arrange for its proper investigation.
