

In producing herewith 08 (Eight) accused persons namely (1) Dipak Sarkar (47) S/O Lt. Jhantu Sarkar, of Haiderpara, Buddha Mandir Road, Ward 40, PS- bhakti Nagar, Darjeeling (2) Santosh Agarwal (56) S/O Lt. I, SI Rana Brahma of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 13.08.2021 at about 00:05 hrs while performing night RT mobile duty. During RT Mobile duty as per order of OC Panitanki OP held raid against violaters of Night curfew order. Accordingly I along with force arrived at Panitanki More and held raid and also checked the various vehicle, and found the above noted arrested persons were moving here and there violating the Govt order of night curfew and without using face mask. On being asked they disclosed their name as (1) Dipak Sarkar (47) S/O Lt Jhantu Sarkar, of Haiderpara, Buddha Mandir Road, Ward 40, PS- bhakti Nagar, Darjeeling (2) Santosh Agarwal (56) S/O Lt. Ramphal Agarwal, of Kanakpur, Neheru Road, PS Thakurganj, Kishanganj, Bihar (3) Bimal Bhattacharjee (48) S/O Lt Madhab Bhattacharjee of South Desh Bandhupara, Ward no. 34, PS- New Jalpaiguri, Jalpaiguri (4) Manoj Agarwal (42) S/O Lt Dilip Agarwal of Kanakpur, Neheru Road, PS Thakurganj, Kishanganj, Bihar. On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and violating the Govt order of night curfew. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/III- ISS/2M-22/2020 and order No-753/II- ISS/2M-22/2020 dated 28/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Dipak Sarkar S/O Lt Jhantu Sarkar, (2) Santosh Agarwal S/O Lt. Ramphal Agarwal (3) Bimal Bhattacharjee S/O Lt Madhab Bhattacharjee (4) Manoj Agarwal S/O Lt Dilip Agarwal (5) Abhirup Barman (26) S/O Bablu Barman (6) Biplab Majumdar S/O Santosh Majumder (7) Birendra Nath Karmakar S/O Lt Dhiren Karmakar and (8) Jaydeb Das Gopinath Das and arrange for its investigation.
