I, SI Hiru Kanti Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Dipak Biswas (45) S/O Late Ashutosh Biswas of Sarbohara Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling to the effect that on 13.08.21 at 08.05 hrs acting on secret information, I received a source information that the above noted person was busy to sale Id liquor illegally at his house situated at Sarbohara Colony under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 814 dated 13.08.21 and informed the fact to I/C Siliguri PS.
