Sub: FIR against the candidates who submitted fake/false documents during the process of engagement of Gramin Dak Sevaks at Department of Posts under Siliguri Sub Division.

In connection to the above mentioned subject and as directed by the competent authority, I, Susanta Bhadra, in the capacity of the Asstt. Supdt. of Post Offices, Siliguri Sub Division would like to lodge one FIR for the reason that during the online selection/engagement process of Gramin Dak Sevak under the Department of Posts of Siliguri Sub Division and in course of document verification it was found that some of the candidates had submitted fake marksheets/documents. Their marksheets/documents were sent to the concerned boards for verification and it was established from the verification report that these marksheets/documents were fake.

The details of such candidates who have submitted fake marksheets/documents are as under:

1. Sri Krishna Biswas, S/o- Late Abinash Biswas, Vill+PO- Matiarkuthi, PS-Ghokshadanga, Dist.-Coochbehar-736157 (Mob. No.-6294613983) had initially been provisionally selected as Gramin Dak Sevak of Buraganj Branch Post Office through the online selection process and later submitted the physical copies of the marksheets/documents (Roll no.-220031100815) for processing of the recruitment procedure. Accordingly the marksheets/documents were sent to the concerned board, viz., National Institute of Open Schooling (NIOS) and on receipt of verification report vide letter no. F.7-104/2021/NIOS/EVAL./M&M/Fake Cert./20 dtd. 14.01.2021 it was established that the marksheets/documents presented by him were fake/false/fabricated and thereby his provisional selection was cancelled accordingly.
2. Smt. Purnima Sarkar, D/o- Sri Nilmani Sarkar, Vill+PO- Matiarkuthi, PS-Ghokshadanga, Dist.-Coochbehar-736157 (Mob. No.-8972446873) had initially been provisionally selected as Gramin Dak Sevak of Buraganj Branch Post Office through the online selection process and later submitted the physical copies of the marksheets/documents (Roll no.-020007911062) for processing of the recruitment procedure. Accordingly the marksheets/documents were sent to the concerned board, viz., National Institute of Open Schooling (NIOS) and on receipt of verification report vide letter no. F.7-104/2021/NIOS/EVAL./M&M/Fake Cert./20 dtd. 14.01.2021 it was established that the marksheets/documents presented by her were fake/false/fabricated and thereby her provisional selection was cancelled accordingly.
3. Ms. Sampsa Biswas, D/o- Sri Sukhlal Biswas, Vill- Chhoto Shimulguri, PO+PS-Ghokshadanga, Dist.-Coochbehar-736171 (Mob. No.-9641807123) had initially been provisionally selected as Gramin Dak Sevak of New Chumta Branch Post Office through the online selection process and later submitted the physical copies of the marksheets/documents (Roll no.-220031911534) for processing of the recruitment procedure. Accordingly the marksheets/documents were sent to the concerned board, viz., National Institute of Open

Schooling (NIOS) and on receipt of verification report vide letter no. F.7-104/2021/NIOS/EVAL/M&M/Fake Cert./20 dtd. 14.01.2021 it was established that the marksheet/documents presented by her were fake/false/fabricated and thereby her provisional selection was cancelled accordingly.

Hence in the above circumstances and as directed by the competent authority, the undersigned desires to lodge an FIR against the above mentioned individuals/candidates who have submitted fake/false marksheet/documents and also take necessary action as deemed fit for their involvement in this serious offence of falsification/forgery of documents.

Your kind office is also requested kindly to supply copy of the FIR at the earliest for further course of action.
