Sir,

In producing herewith the following seized articles viz- i) 07 nos. of plastic bags containing Red Chilli Powder styled & labeled as Jay Sri containing 3500 packets @ 50 grams each marked as Exhibits -A, ii) Two packets Red Chilli Powder styled & labeled as Jay Sri containing 100 grams was taken from Exhibits -A as sample marked as Exhibits-A1, iii) 29 Plastic bag of Holdi (Turmeric) powder containing 50 KG each marked as Exhibits-B, iv) 100 grams of Turmeric powder was taken from Exhibits- B as sample marked as Exhibits- B1, v) one plastic bag of Red Chili containing 50 Kg each marked as Exhibits- C, vi) 100 grams of Red Chili was taken from Exhibits- C as sample marked as Exhibits- C1, vii) 04 bundle of sticker styled as Roy-S1 Holdi Turmeric powder marked as Exhibits-D, viii) one Bundle of sticker styled as Joy Sri Dhania Powder marked as Exhibits-E, and ix) one bundle of sticker styled as Joy Sri Red Chili Powder marked as Exhibits F as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against Shiv Agarwal S/O Sri Purusuttam Agarwal of Sukanta Sarani, Milanpally, Ward No. 26, PS- Siliguri Dist- Darjeeling that on 13.08.21 at 11.35 hrs received a secret source information that one person namely Shiv Agarwal of Sukanta Sarani, Milanpally, Ward No. 26 under Siliguri PS stored huge quantity of adulterated Holdi and Red Chili powder in his godown in order to sale clandestinely the same. Accordingly the fact is informed to I/C Siliguri PS vide Siliguri PS GDE no. 826 dated 13.08.21. As per his direction I along with PSI Rajiv Subba, ASI Siben Sarkar, CV- 283 Prosenjit Dey and CV/622 Ramanath Barman left for Sukanta Sarani, Milanpally, Ward No. 26 under Siliguri PS vide Siliguri P.S GDE NO: 827 to verify the veracity of the information. I reached at 12.00 hrs at Sukanta Sarani, Milanpally, Ward No. 26. As per source information a raid was conducted at the Godown of Shiv Agarwal S/O Sri Purusuttam Agarwal of Sukanta Sarani, Milanpally, Ward No. 26, PS- Siliguri Dist- Darjeeling who was not present in his house. During search I found that the above noted articles which were kept concealed in the said Godown. It is learnt that the above noted person was selling the said adulterated Holdi and Red Chili powder mixed with noxious colour and chemical for his better profit being fully aware of the fact that it could be cause harm to the buyers after consumption. Accordingly I seized and labeled the above noted articles under proper seizure list.

Under the circumstances I pray that a specific case against absconding accused person namely Shiv Agarwal S/O Sri Purusuttam Agarwal of Sukanta Sarani, Milanpally, Ward No. 26, PS- Siliguri Dist- Darjeeling under proper section of law and arrange for its investigate.
