Nilam Devi @ Neelam Devi Prasad@ Nilam Prasad Wife of Sri Ram Dyal Prasad, Presently residing at C/O Sri Laxman Prasad Praffula Bala Apartment, By lane, Near Subrata Sangh Club, P.O & P. S. Siliguri , Dist- Darjeeling and Permanent resident of Vill- Sainkaswa, P.O. Sain, Via Kanti, P.S. Kanti, Dist. Muzaffapur (Bihar) do hereby submit the following for your kind information & necessary action:-That I am a legally married wife of Late Ram Dayal Prasad and out of our said marriage Four daughters were born namely 1) Popnam Prasad, 2. Sunita Prasad, 3) Sandhya Prasad and 4) Artai Prasad. That my said husband Ram Dyal Prasad was working in MES, Sevoke Road. P-O- Salugara, Dist-Jalpaiguri sand my name is recorded in the Service Records and my husband retired from MES Service in the year 31-12-2019. That my said husband during his life time & service period had an illicit relation with one woman namely Shanti Prasad who /was residing at Shivrampally, Haiderpara, P.S. Bhaktinagar, Dist-Jalpaiguri and out of which Two children were born namely Shneha Prasad and Akash Prasad. That my said husband received huge amount from his office after retirement but Shneha Prasad and Akash Prasad snatched & took all the said amount and transferred in their Account in an illegal & unlawfully manner by using criminal force and my husband was mentally & Physically tortured by the two children but Smt. Shanti Prasad could not tolerate the inhuman behavior of her two children and a result of she died of Brain Stroke on 10-11-2020 and after the demise of Shanti Prasad my husband asked us to reside at Shiyrampally, Haiderpara, P.S. Bhakti Nagar, Dist-Jalpaiguri. That my said husband was always mentally & physically tortured by Shneha Prasad & Akash Prasad for money with the help of one boy namely Nilidary Roy, who is the boy friend of Shucha Prasad. And my said husband was in State of depression after the demise of Smt. Shanti Prasad and thereafter I along with my said daughters looked after my husband but Shneha Prasad & Akash Prasad did not look after my said husband and they mercilessly assaulted &tortured continuously to my husband and as a result his leg was factured and there after he was admitted to one namely Maya Sanyal Nursing Home, Siliguri for treatment. Thereafter Shneha & Akash clandestinely & forcibly took the Signatures of my husband on some Blank Cheques and Blank papers for their ulterior motive so that they can withdraw all the amount from Banks without informing any one. My said husband informed all the matters about their ill motive to me and my two daughters namely Poonam Prasad, and Sunita Prasad when he was in hospital. That at the beliest of my husband we did not inform the matter to the Police and therefore we kept mum then but all of a sudden my husband died on 01-12-2020. Neither Shneha Prasad nor Akash Prasad visited my husband at the said Nursing Home during his life time and it is presumed that they were busy in collecting/ hiding all documents including LIC Policy, Bank Pass Book, ATM Cards, Cheques Books etc of my husband for their ulterior motive as well as illegal gain so that I along with my other daughters may not claim anything after the demise of niv said bushand that before retirement from his Service my husband prepared all necessary documents & obtained my finger prints as well as signature and a Joint Bank Account was opened by my husband with me at Union Bank of India, Hakimpara Branch, Siliguri, being Account No SSSID D10005081 for Pension purpose. That after performing the rituals ceremony of my deceased husband, Shneha and Akash made hatched a conspiracy with the help of Niladray Roy i.e. boyfriend of Shenha Prasad and dragged us out of the house and I dinding no other alternative & returned to our village. That in the month of March 2021, I came to Siliguri and visited the MES Office Salugara of my husband for pension purpose and for financial dues and the office informed that they would look into the matter. 10. That in the month of March 2021. I went to the Union Bank of India Hakimpara Branch to withdraw some amount for my survival and I asked the Manager whether my further dues was - reached at the bank or not and he advised me to visit the MES OFFICE and I returned to my said
