In producing herewith one accused person namely Ajit Kumar Paswan-(20 yrs.), S/O Lt. Shivji Paswan, of Patthar Patti, Chhatwan, Darbhanga, PS- Keoti Dist - Darbhanga(Bihar) along with the following seized articles as per proper seizer list:

1. 17(Seventeen) pet bottles of Himalaya Gold 60up premium country spirit ( each bottles containing 300 ml. & MRP Rs 50/-)

I ASI Sanjay Hasda of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 13.08.2021 at 18:25 hrs. received an information from santoshinagar near Ramjanki Mandir, W/NO-05, under Siliguri PS that one person has gathered huge quantity of illegal liquor which kept in his C/O Jhari Paswan of Santoshinagar near Ramjanki Mandir, W/NO-05, under Siliguri which was kept in one gunny bag for selling the same in the open market for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO -444/21, Dated-13.08.2021. As per your kind instruction myself along with ASI Niranjan Sarkar, C/ 466 Tarun Pahan and proceeded to the PG to work out the information. At 18:45 hrs. we reached at the near santoshinagar near Ramjanki Mandir, W/NO-05 sometimes after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell he same in open marked for his wrong full gain. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample.

(The seizure was made in between 18:55hrs to 19:30hrs.) I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Ajit Kumar Paswan-(20 yrs.), S/O Lt. Shivji Paswan, of Patthar Patti, Chhatwan, Darbhanga, PS- Keoti Dist - Darbhanga(Bihar) under proper section of law and arrange for investigation.
