Kishanganj, Bihar (2) Md Jawed (42) s/o Md Nijamuddin of Kishangang Bazar Ps Kishanganj Dist. Kishanganj, Bihar (3) Tek Bahadur Gurung (39) s/o Bhim Bahadur Gurung of Mangzing Busty Ps Limdoo Dist. Sikkim (4) Santu chakraborty (26) s/o Dilip Chakraborty of Medinipur Boro Bazar Ps Kotwali Dist. Pashim Medinipur and (5) Bindey Sahani (29) s/o Lt. Debrath Sahani of Thanjhora 3 No. Line Ps Kharibari Dist. Darjeeling under arrest u/s 41 Cr.P.C. and do hereby lodge a written complaint against them.

In this regard, I SI Dipankar Chakraborty of Bagdogra PS, SPC that on 14.08.21 at 14-05 hrs I alongwith ASI Dilip Holder and force van-II mobile van were performing duty in connection with violating the order of Lockdown and moving without facial Mask vide Bagdogra PS GDE No.1048 dt. 14.08.21 at Bihar More and found that some persons were moving without facial Mask and violating the order of Lockdown, Accordingly I shared the information with you and as per your direction, in between 14-35 hrs. to 15-45 hrs I alongwith with VAN-II mobile officer and force arrested the above noted persons who were moving freely without Facial Mask on the spot completely violating the lockdown measures issued by the appropriate authority On seeing police also, the above noted persons were causal and negligent to wear Facial Mask and moving here and there. I repeatedly cautioned them and warned them to wear Mask but they did not listen rather showed negligent and casual attitude and their unlawful movement found likely to spread covid -19 dieses which is dangerous to life. Then above noted persons could be apprehended. On interrogation, they all disclosed their names and address as noted above. On further grilling, they all admitted that they all were aware of the order to wear facial Mask in public place . As they had violated the order of lockdown promulgated by the appropriate authority vide order No. 647-ISS/2M-22/2020 dated 15.05.21 and Memo No. 486-CS/2021 dated 24° April , 2021 and also the provisions of disaster Management Act, 2005, I with the help of force arrested them u/s 41 Cr.P.C. preparing proper memo of arrest.

I therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
