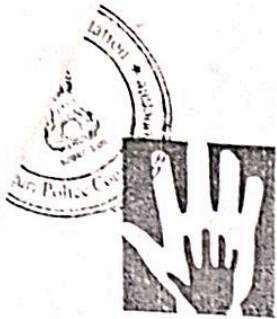

With due respect I Cecilia Kujur Transit Monitoring Staff TINY HANDS INDIA Siliguri this is to bring your knowledge that today, On 10/8/2021 (time) at 12pm one minor girl has been recovered from Bihar Bus Stand, Siliguri, during our outreach she came to noticed as she was sitting in a ticket counter along with the girl name Sheha khariya age 20 D/O Kiran khariya address Dima T.E Bichline P.O Kalichini bichline Dist Alipurduar we counsel her because she was an adult. According to them they were heading to Sewan Bihar for musical event. But the minor girl didn't have any proper idea of the address where they were travelling; she has a fake Adhaar card. The boy from Bihar made all arrangement for her and adhaar card as well. So took them to our sub office for more counselling. During the interrogation we came to know that the girl name Smita oraw D/O Dalkumar Garopara Dist Alipurduar was incited by a lady name Santi khariya from Garopara kalchini for orchestra in Bihar it will pay good payment to her, because there is no income source in the family. Therefore, after viewing this we came to the point in regard of her safety and protection, as she is a minor and without the consent of her parents she was travelling to Bihar in her own risk. But according to our assumption that she might have been trafficked or mislead by taking the advantage of her weakness. As per the telephonic conversation with CWC member Mr. Milan Chettri Darjeeling has directed to lodge the GDE at near P.S for further necessary support of the said child.

Therefore here, we are lodging G.D.E in favour of the girl, here you are requested to do further investigation with concern authorities and make all proper procedure to send them back to their home safely.
