In producing herewith ^{Two} ~~four~~ (02) arrested accused persons namely (i) Krishna Singha (25), S/O Kaltu Singha of Chotodukhuria, PO - New Chumta, PS - Matigara, Dist - Darjeeling and (ii) Narayan Barman (23), S/O Ashok Barman of Panchkelguri, PO - Nemaajote, P.S - Matigara, Dist - Darjeeling were loitering arrested u/s 41 Cr.P.C.

I, SI Md. Sanaullah of Matigara PS SPC to the effect that on 16.08.2021 while performing SPL Mobile duty under Matigara PS area found two persons namely (i) Krishna Singha (25), S/O Kaltu Singha of Chotodukhuria, PO - New Chumta, PS - Matigara, Dist - Darjeeling and (ii) Narayan Barman (23), S/O Ashok Barman of Panchkelguri, PO - Nemaajote, P.S - Matigara, Dist - Darjeeling were loitering near City Centre, under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.403/2020-DM-1 (A) Date-29.04.2021. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely (i) Krishna Singha (25), S/O Kaltu Singha of Chotodukhuria, PO - New Chumta, PS - Matigara, Dist - Darjeeling and (ii) Narayan Barman (23), S/O Ashok Barman of Panchkelguri, PO - Nemaajote, P.S - Matigara, Dist - Darjeeling proper section of law and arrange for its investigation.
