Sub: - Causing grievous Hurt with an intent to loss of life of a Pregnant lady bearing child of 6 months, Using Filthy and derogatory Threats and Damage to property and putting the life of people in grave threat and peril by Namely Sambhu Sahini, Tapeshwar Sahini, Raj karan Singh, Krishna Singh and Somenath Singh.

Dear Sir,

With due respect I, undersigned **Ranjit Rajak S/O Siya Ram rajak Resident of Prakash Nagar, Durga Mandir Road under P.S. Bhaktinagr** would like to request you that on 8<sup>th</sup> of August 2021 at about 8:00 PM and again on 9:30 PM on the very same date, a few nefarious/miscreants goons **Namely Sambhu Sahini, Tapeshwar Sahini, Raj karan Singh, Krishna Singh and Somenath Singh** came to my house with around 20 to 25 people and surrounded us with an intention unknown at that moment and later within a minute they started using abusive words and filthy languages and heckling me and my associate namely **Binod Kumar Mahato S/O Budhan Mahato & Manteshwar Burman** who was present there, the manner in which at first they heckled and harassed us was fearsome and when we tried to calm them they assaulted us and used physical force and grabbed us with collar and created an atmosphere where it seemed that we might lose our life and in that process we tried to escape back in our house/residential premises along with Me i.e **Ranjit Rajak, Binod Mahto and Manteshwar Barman** but during the event of escape they forcefully barged into our house and obstructed us from closing the metal gate/door which is the entry point. They got hold of the gate and with an intent of **battering us** they managed to get inside and started to assail out on us, the outbreak was terrifying and one of our associate that is **Manteshwar Barwan** while trying to protect himself fell prey to their ferocious and cruel use of their ganged up assault as a result of which he was severely injured and which resulted in bleeding and got unconscious and was in that state for a period hard to remember and in that moment and in an attempt to escape we managed to lock ourselves up under our house and somehow managed to push them out after that a Neighbour Namely who had seen this event, **Lal Babu Gupta** informed the Bhaktinagar P.S. about the ongoing incident and before they arrived the nefarious miscreants left the scene (hiding and not visible through naked eye) and they inspected the place of accident

and were present there for around 30min and this part of the incident took place at 8:00 Pm.

Later after an hour or more at around 9:30PM they came back with a force of over 30 men with Metal rods and other other heavy tools which was hard to identify after the Police patrolling Van left the place and started pelling our house with heavy bricks and other throwable objects and because of which Poonam Rajak a pregnant lady of 6 months W/O Ranjit Rajak got hit by a few stones and due to which she suffered a few injuries and fell in a state of shock as she was carrying baby and she felt she might lose her child. The aforesaid situations led to panic and a state of arrest where neither we can move nor we can step out we felt being house arrest within our own premises, we stayed put and morn with our hearts to our mouth and felt that we might not see another morning the people outside my house basically the hooligans they were yelling and shouting and abusing us and trying to provoke us to come out of our house but we knew that it might end up worse.

The hooligans/assailants were orchestrated by Namely Sambhu Sahini, Tapeswar Sahini, Raj karan Singh, Krishna Singh and Somenath Singh destroyed the property of Manteshwar Burman Owned By his Father i.e Mohan Burman completely, which was his vegetable store and which was his only source income, which helped his family of 5 to feed and survive and while destroying so they looted Rs.10,000/- from his counter as well.

And at around 12:30 AM we left from our house to visit Sadar hospital so that we can provide some urgent medical aid to Manteshwar Burman who was badly injured and was admitted by Binod Kumar Mahato.

They have given life threats to me/undersigned and while doing so they have created an atmosphere of chaos putting the life of the undersigned in peril.

The neighbours namely Lal Babu Gupta, Bipin Gupta, Harinder Choudhary and Umesh Mahato are all witness to these incidents.

I feel concerned about the situation as it affects me as well as others due to the ordeal created by Namely Sambhu Sahini, Tapeswar Sahini, Raj karan Singh, Krishna Singh and Somenath Singh. It has affected many in the past and has caused tremendous trouble to existing and has made my life almost impossible and now time has come to take cognizance of their behavior and enforce strict action.
