With due respect, I, Mr. Devanand Paswan (45years) Son of Late Chedi Paswan resident of Ram Krishna Colony II, Junction Siliguri, and in my family I have one daughter 18 years, one son (14years) and another son is just (8years) old and my family totally dependable upon me, I work as a security Guard in the company of staff security Guard Service, it's Govt. Registered no. 73649 and I am sited to in Bhagwati Apartment-I, Siv Mandir Road, at Punjabi para, and I am a salaried person, my salary is just Rs. 6,000/- per month and I manage on this, of my family maintenance.

Sir, when I was doing in duty in the evening at 8 O'clock on 02.08.2021, I have meet with an accident with one blue or black **Motor Cycle bearing no. WB 74 Y6178** and after accident they run away and I was lying on the road side and one secretary boy of our apartment Mr. Sapan Shaw pick me up.

Thereafter, at 9 O'clock two staff of that apartment one is field officer Mr. Hemanta and other is Secretary Mr. Sapan Shaw both took me to the Civil Hospital of Siliguri for the treatment, and after checkup the Doctor told me that I have got a fracture at my ankle and it is a case of Operation, so, they should be admitted in the Hospital and the Operation is an expensive Operation, then I admitted in the Civil Hospital in the morning but I take discharge of myself in
