Sir,

In producing herewith one accused person namely Jayanta Dey-46yrs s/o Lt Judhistir Dey of Subhashpally, Near Bazar ward No-19 PS, Siliguri Dist Darjeeling along with the following seized articles as per proper seizure list:

1. One cartoon of Budweiser beer containing 12 (twelve) bottles each bottle containing 650 ML.
2. Four cartoons of Kingfisher strong Beer each cartoon containing 12 (twelve) bottles and each bottle containing 650 ML
3. Three cartoons of TUBORG strong premium beer each cartoons containing 12 bottles and each bottle containing 650 ML.
4. One Blue & White colour Toto vide Registration No-WB73F/1501

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Jayanta Dey-46yrs s/o Lt Judhistir Dey of Subhashpally, Near Bazar ward No-19 PS, Siliguri Dist Darjeeling to the effect that on 14.08.21 at 16.15hrs received a source information from Sevoke road, Don Bosco More under Bhaktinagar PS that one person was coming from Cosmoss Mall side towards Don Bosco more through a Toto Rickshaw with huge quantity of liquor for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-813 dated 14.08.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 16.25 hrs we reached at the Don Bosco more under Bhaktinagar PS, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession which was kept in his Toto. During local enquiry it came to learn that he was going to reach the same to one Prabin Luis of Bikashnagar who was selling the liquor in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities in presence of. (The seizure was made in between 17.40 to 18.50 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Jayanta Dey-46yrs s/o Lt Judhistir Dey of Subhashpally, Near Bazar ward No-19 PS, Siliguri Dist Darjeeling & Prabin Luis of Bikashnagar under Bhaktinagar PS Dist Jalpaiguri under proper section of law and arrange for investigation..
