Respected Sir,

With due respect, I, SRI KALYAN MITRA, Son of Late Kartick Chandra Mitra, Resident of Rabindra Nagar Main Road, Ward No. 22 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Siliguri, Dist Darjeeling and also being the member of the Board of Directors of C.C. Com Pvt. Ltd. popularly known as CCN, having its Office situated at Haren Mukherjee Road, Hakim Para, Siliguri would like to lodge this written complaint to the effect that we are celebrating the Inauguration Date of C.C. Com Pvt. Ltd. on the day of 15th August every year and like previously years, this year also we are celebrating our inauguration Day this year and in the evening time, we have arranged and organized a get together party amongst the members of the Directors of CCN including the members of the Board of Directors at Amrabati Hotel at S.F. Road, Siliguri and most of the Directors including the Board of the Directors were present in the said get together party in the evening time and after completion of the said get together party, when myself along with other members and Board of Directors of the C.C. Com Pvt. Ltd. namely Sri Aparesh Saha, Sri Samarendra Ghosh, Sri Chhatu Prasad Gupta and others came in the down stairs of the said hotel and at about 10.00 P.M., when we were sit in the vehicle in order to return to our respective house, we found that one vehicle was coming from Jalpai More Side to towards Sligari P.S. Side in the wrong way and stopped the said vehicle in front of our vehicle and we also noticed that one of our Ex- Board Member namely Sri Sunil Kumar Chourasia came out from the said vehicle in a fully intoxicated condition and started to abuse and threaten us with filthy slang and abusive languages and when we raised our objection against his said illegal acts and behavior, he became furious and started to assault me and other members of

the Board of Directors with fist and blows and at that point of time, one police vehicle was also crossing the said area and seeing the said situation, the said police van stopped the said police vehicle and restrained him from assaulting ourselves and thereafter, the police team brought him at Siliguri Police Station. Due to the said assault, myself and my friends have received some injury on our persons and still now, I am feeling pain on my chest. It is to be mentioned here that since in the year of 2000, the members of Board of Directors have been selected through Election procedure and previously, Mr. Sunil Kumar Chourasia was selected as a member of the Board of Directors but in the present year, he lost in the election and members did not select him as a member of the Board of Directors and since then, he has started to threaten us with dire consequences and also created disturbance for smooth running of our companies activities and as the members did not select him as a member of the Board of Directors, on 15th August, 2021, in the evening time, when we were returning towards our house after completion of the get together party, he intentionally abused us and assaulted us physically and also threatened us to implicate the members of the Board of Directors in a false case.

I, therefore, request you to kindly investigate into the matter and please take necessary legal steps against said Mr. Sunil Kumar Chourasia in accordance with law and obliged thereby.
